Please read the following carefully.

I agree to Jerusalem Creek Marina and Holiday Park Rules and Policies which state that pet owners:

A4 The keeping of pets and wildlife

- A4.1 May not have a pet in the Holiday Park and Marina without first obtaining the holiday park and marina owner's written consent with respect to a specific pet.
- A4.2 Must dispose of any animal wastes promptly and appropriately. A fine of \$100.00 applies to offending owners.
- A4.3 If required, provide the Holiday Park and Marina owner with a written guarantee that their pet does not represent a danger to the health and safety of other Park and Marina users, in particular young children, who may wander into an animal's territory.

- A4.4 Must not leave a pet unattended unless absolutely necessary. If it is necessary, every effort must be made to arrange for someone to monitor the pet's behavior and well being. Dogs and pets left unattended must
 - a) be on a lead
 - b) have access to a shelter and shade.
 - c) be provided with adequate food and water.
- A4.5 Must keep their pet under control at all times.
- A4.6 Must not allow a pet to be in or near the Park's communal facilities.
- A4.7 Must not allow a pet to enter a hired dwelling.
- A4.8 Must ensure that cats are neutered and wearing a bell unless they are confined at all times.
- A4.9 Must not allow a pet to be a nuisance or cause distress to other Holiday Park and Marina users.
- A4.10 Dogs must be walked on leads at all times, and under no circumstances are dogs allowed to roam freely within the park or marina.
- A4.11 Native and local animals must not be harmed in any way, if there is cruelty or pain and suffering caused to native and local animals it is deemed to be a breach of the essential terms of the holiday park and marina occupant agreement.
- A4.12 Dangerous animals are in and around the Holiday Park and Marina. Holiday Park and Marina occupants and their visitors are not to interfere with their habitat or attempt to remove such animals. In situations of potential harm to humans the holiday park and marina occupants or their visitors are to inform the Holiday Park and Marina owner immediately. The Holiday Park and Marina owner will undertake removal of such animals in accordance with local laws.
